#### Friends for Life Bedfordshire

60% of people in care homes typically receive no visitors Studies suggest feelings of loneliness greatly increase the chances of developing dementia Friends for Life Bedfordshire is the only charity in Beford working to address social isolation in care homes

The social isolation of care home residents is a hidden emotional crisis in communities across the UK. Care home residents live on the fringes of society, away from the public eye, and a significant number of residents receive few or no visitors for months and even years.

Since 2007, Friends for Life Bedfordshire has been working to reduce the social isolation of people in Bedford's care homes. We recognise the negative impact loneliness has on a person's wellbeing, and address this by recruiting and training personal befrienders who offer friendship and company to residents most at risk of loneliness. We also facilitate school-care home partnerships, which provide inter-generational social interaction.



## Agents for Change - Meet Anne

Anne has spent her life caring for her family. Today, Anne, a wife and mother, finds herself alone and living in care.

With the death of her husband, and her daughter living abroad, Anne can no longer live at home. Struggling to adapt to living in care, and with no one to visit her, Anne needs someone who can offer her their time and friendship.

Thanks to our befriending service, Anne now receives visits from her befriender Stella every week. As well as providing Anne with the company and conversation she desired, Stella has enabled Anne to spend regular time outside the care home environment through trips to the local park, shops, coffee shop and down to the river for fish and chips at lunchtime!


## How you can leave Friends for Life Bedfordshire a gift in your will

We know that family and friends always come first. After you've made sure you have provided for your loved ones in your will, you may be happy to consider leaving a gift in your will to Friends for Life. There are many ways you can do this, making your gift in your will as individual as you are.



This is simply a sum of money, large or small, that you wish to leave. A pecuniary gift will depreciate over time, so if you are including such gifts in your will, it may be worth reviewing their value every so often to make sure they still reflect your wishes.

## Residuary gifts

With this gift you leave apercentage share of your estate, once your family, friends anddebts have been taken care of.Many people prefer residuary gifts, as leaving a percentage of theremainder of your estate is a simpleway to give a gift of real value.

## Contingent gifts

Legacies made on the basis of another event happening first are called contingent gifts. For example, your will could state that a gift only applies if all other benefciaries die before you do

## Specific gift

A specific legacy is the gift of a particular item, and could be furniture, antiques or jewellery

We'd always advise you to consult with a qualified solicitor when drawing up your will, or when making amendments, as they can guide you through the legal language and ensure your wishes are clear.

## Our legacy promise to you

A gift in your will is a promise to reduce the social isolation of care home residents for generations to come. It is a promise to reach out and find people who are alone and offer them the gift of friendship.

#### Keeping up to date

We appreciate that circumstances in life change and that it is important to review your will after any significant change of events to ensure it reflects your current situation and wishes.

When reviewing your will, this is an ideal opportunity to include a gift to Friends for Life Bedfordshire. Deciding to leave a gift to us doesn't automatically mean you will need to create a new will as sometimes all that is needed is the addition of a codicil. A codicil is a document that makes an amendment to your will without the need for it to be rewritten.
